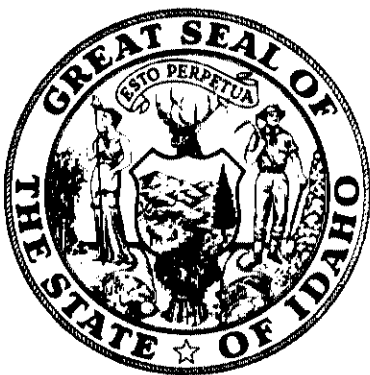

ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
AMERICAN BANK OF COMMERCE

Pursuant to the provisions of Section 30-1-61, Idaho Code, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is American Bank of Commerce.

SECOND: The following amendment to the Articles of Incorporation was adopted in the manner prescribed by Section 30-1-59, Idaho Code, on August 21, 1981:

RESOLVED, that the Articles of Incorporation of American Bank of Commerce be amended by deleting therefrom in its entirety Section 9 of Article V.

THIRD: At the time of such adoption, there were 103,500 shares of the corporation outstanding and entitled to vote thereon; all of said shares voted for such amendment.


