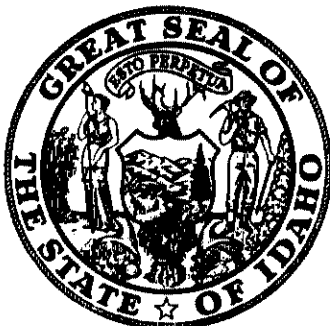
CERTIFICATE OF INCORPORATION OF

The undersigned, a natural person licensed to practice medicine in the State of Idaho, acting as incorporator under the Idaho Professional Service Corporation Act, adopts the following articles of incorporation:

**ARTICLE I.
NAME OF CORPORATION**

The name of the corporation is Snake River Physicians, P.A. ("Corporation").

**ARTICLE II.
DURATION**

The Corporation shall have perpetual existence.

**ARTICLE III.
PURPOSES OF THE CORPORATION**

The Corporation is organized for the following purposes:

1. To engage in the practice of medicine and allied professional services.
2. To do any acts and perform any business permitted by the Idaho Professional Service Corporation Act.

**ARTICLE IV.
