THE UNDERSIGNED PERSONS, ARTHUR RICK VOLLWEILER, as President, and ARTHA LEE CHIPPS, as Secretary, do submit these Articles of Amendment amending the previously filed Articles of Incorporation for said corporation to reflect the desires of said shareholder to amend the corporate name.

I

The name of the corporation as it was originally set out was and is ART'S MACHINE SHOP, INC.

II

That on the 23rd day of February, 1993, the Articles of Incorporation were amended, at a meeting duly called for that purpose, by a unanimous vote of all of the outstanding common stock at the company headquarters in American Falls, Idaho, at the hour of 10:00 a.m., to change the name of the corporation from ART'S MACHINE SHOP, INC. to ART'S MANUFACTURING & SUPPLY, INC.

That only 2,000 shares of one class of stock has been issued, namely common stock and Arthur Rick Vollweiler is the owner of all of said stock.

That following a roll call vote, it was determined that a quorum was present and voting, and it was duly moved, seconded, and carried by unanimous vote that the foregoing amendment to the Articles be made and the name of the corporation be changed to ART'S MANUFACTURING & SUPPLY, INC.

That save and except for the foregoing amendment, the Articles of Incorporation are herewith ratified as originally filed.


