WHEREAS, there has been filed with and presented to the Board of County Commissioners of Blaine County, Idaho, a petition to incorporate the Village of Sun Valley, Idaho, said petition having been duly signed by taxable inhabitants within the territory described in said petition, praying that they may be incorporated as a village under the laws of the State of Idaho, and in which petition they designate the name of Sun Valley as the name they wish to assume, and describe with particularity the territory to be included therein, giving the metes and bounds of the proposed Village, being as hereinafter more particularly described; and

WHEREAS, it appearing to the Board that there are more than one hundred twenty-five actual residents residing within the territory described in said petition, and that more than a majority of the taxable inhabitants of said territory therein described signed said petition, and that said petition is in all respects true and correct and in full conformance with the statutory requirements, and the prayer thereof ought to be granted.

NOW, THEREFORE, IT IS HEREBY ORDERED that there be, and is hereby created, established and incorporated a village within the County of Blaine, State of Idaho, which is comprised of territory within the metes and bounds more particularly described as follows, to-wit:

Beginning at the intersection of the Northeasterly boundary line of the Village of Ketchum with the west line of Government Lot 1, in Section 18, Township 4 North, Range 18 East of the Boise Meridian in Blaine County, Idaho;

thence north along said west line of Government Lot 1 in Section 18 and the west line of the East Half of the West Half ($E\frac{1}{2}$ of $W\frac{1}{2}$) of Section 7 in said township and range, to the northwest corner of the Southeast Quarter of the Northwest Quarter ($SE\frac{1}{4}$ of $NW\frac{1}{4}$) of said Section 7;

thence East along the North line of said Southeast Quarter of Northwest Quarter ($SE\frac{1}{4}$ of $NW\frac{1}{4}$) of the Northeast corner thereof;

thence North along the West line of the Northwest Quarter of the Northeast Quarter ($NW\frac{1}{4}$ of $NE\frac{1}{4}$) of said Section 7 to the north line of said section;

thence East along the North line of said Section 7 to the Northeast corner of said Northwest Quarter of the Northeast Quarter ($NW\frac{1}{4}$ of $NE\frac{1}{4}$);

thence North along the West line of the Southeast Quarter of the Southeast Quarter ($SE\frac{1}{4}$ of $SE\frac{1}{4}$) of Section 6, in said township and range, to the northwest corner thereof;

thence East along the North line of said Southeast Quarter of the Southeast Quarter ($SE\frac{1}{4}$ of $SE\frac{1}{4}$) of said Section 6 to the Northeast corner thereof;

thence North along the West line of the Northwest Quarter of the Southwest Quarter ($NW\frac{1}{4}$ of $SW\frac{1}{4}$) of Section 5, in said township and range, to the northwest corner thereof;

thence East along the north line of said Northwest Quarter of Southwest Quarter ($NW\frac{1}{4}$ of $SW\frac{1}{4}$) of said Section 5 to the Northeast corner thereof;

thence North along the West line of the East Half of the Northwest Quarter ($E\frac{1}{2}$ of $NW\frac{1}{4}$) of said Section 5 to the North line of said section;

thence East along the North line of said Section 5 to the East line of the West Half of the Northeast Quarter ($\frac{1}{2}$ of $\text{NE}\frac{1}{4}$) of said section;

thence South along the East line of said West Half of Northeast Quarter ($\frac{1}{2}$ of $\text{NE}\frac{1}{4}$) of Section 5 to the South line of said Northeast Quarter ($\text{NE}\frac{1}{4}$);

thence West along the South line of the Northeast Quarter ($\text{NE}\frac{1}{4}$) of Section 5 to the Southwest corner thereof;

thence South along the North and South center line of said Section 5 to the South line of said section;

thence West along the North line of Section 8 in said township and range, to the East line of the West Half of the West Half ($\frac{1}{2}$ of $\text{W}\frac{1}{2}$) of said section;

thence South along the East line of said West Half of the West Half ($\frac{1}{2}$ of $\text{W}\frac{1}{2}$) of Section 8, to the south line of said Section;

thence South along the East line of the Northwest Quarter of the Northwest Quarter ($\text{NW}\frac{1}{4}$ of $\text{NW}\frac{1}{4}$) of Section 17 in said township and range, to the southeast corner thereof;

thence west along the south line of said Northwest quarter of Northwest Quarter ($\text{NW}\frac{1}{4}$ of $\text{NW}\frac{1}{4}$) of Section 17 to the Southwest corner thereof;

thence South along the East line of the Southeast Quarter of the Northeast Quarter ($\text{SE}\frac{1}{4}$ of $\text{NE}\frac{1}{4}$) of Section 18 in said township and range to the southeast corner thereof;

thence west along the south line of said Southeast quarter of Northeast Quarter ($\text{SE}\frac{1}{4}$ of $\text{NE}\frac{1}{4}$) of Section 18 a distance of 1260 feet to a point thereon;

thence north a distance of 2987.5 feet;

thence N. $75^{\circ} 57'$ E. a distance of 731.9 feet;

thence N. $5^{\circ} 12'$ E. a distance of 552.3 feet;

thence east a distance of 500 feet to a point on the east line of the Southeast Quarter of the Southeast Quarter ($\text{SE}\frac{1}{4}$ of $\text{SE}\frac{1}{4}$) of Section 7 in said township and range;

thence north along said East line of the Southeast quarter of the Southeast Quarter ($\text{SE}\frac{1}{4}$ of $\text{SE}\frac{1}{4}$) of Section 7 to the Northeast corner thereof;

thence West along the North line of said Southeast Quarter of Southeast Quarter ($\text{SE}\frac{1}{4}$ of $\text{SE}\frac{1}{4}$) of Section 7 to the Northwest corner thereof;

thence South along the East line of the Southwest Quarter of Southeast Quarter ($\text{SW}\frac{1}{4}$ of $\text{SE}\frac{1}{4}$) of Section 7 and the Northwest Quarter of the Northeast Quarter ($\text{NW}\frac{1}{4}$ of $\text{NE}\frac{1}{4}$) of Section 18 to the Southeast corner of said Northwest Quarter of Northeast Quarter ($\text{NW}\frac{1}{4}$ of $\text{NE}\frac{1}{4}$) of Section 18;

thence West along the South line of said Northwest Quarter of Northeast Quarter ($\text{NW}\frac{1}{4}$ of $\text{NE}\frac{1}{4}$) of Section 18 to the Southwest corner thereof;

thence South along the East line of Government Lot 3 in said Section 18 to the Southeast corner thereof;

thence West along the south line of said Government Lot 3 to the easterly boundary line of the Village of Ketchum;

thence northerly and Northwesterly along the Easterly and Northeasterly boundary lines of the village of Ketchum to the point of beginning.

IT IS FURTHER ORDERED that the name by which said village shall be known and designated is and shall be SUN VALLEY, and that the said Village of Sun Valley from the date hereof shall have all of the rights, powers and immunities provided by the laws of the State of Idaho, and shall be governed by the provisions of said law applicable to the government of villages.

IT IS FURTHER ORDERED that W. P. Rogers, E. F. Seagle, Dr. John R. Moritz, Winston McCrea and Florence Reilly Rider, persons duly qualified to act as trustees, be, and they are hereby appointed as


