KNOW ALL MEN BY THESE PRESENTS: That we, whose names are hereto subscribed, do under and by virtue of the laws of the State of Idaho, organize, constitute and associate purcelves into a body comporate, to be known as the SOUTH-SIDE BRUNEAU CANAL COMPANY, LIMITED, for the purposes of doing business as such corporation within the state of Idaho.

FIRST;

The name of this corporation and its corporate title under which it will transact its business is the SOUTH-SIDE ERUNDAU CAMAL CONFIDER, LIGHTED, and its corporate seal shall be so marked.

SECOND;

The principal place of business and the principal office of the Company shall be in the town of Bruneau, Swyhee County, State of Idaho.

THIRD ;

The purposes and objects of this Corporation are to deal in lands and waters, water rights and franchises and other real property in the State of Idaho, to buy, bond, lease, rent or otherwise acquire lands, realty or personal property, and to sell, bond, lease, mortgage, convey in trust or hymothecate real estate, water rights, franchises or personal property, and to sell, bond, lease, mortgage, convey in trust or hypothecata the same for themselves or others, and to act as agent, trustoo, assisteee, receiver, quardian, conservator, executor or administrator, in the care, custody, protection, sale, rental, lease, bonding or hypothecating of the sale; to advance money for the purchase or improvement of lands or the construction or repair of dans, laterals and canals, and for the rental or purchase of water rights or the use of water, or any rights therein. In its corporate name, to acquire legal or equitable rights in lands or water or water rights or any interests therein, or real or personal property by location, purchase or judgment or by decree of Court or otherwise, and generally to acquire rights in lands and improvements, water rights and franchises and personal property in the ordinary course of business.

To deal in personal property and the buying and the selling of the same. To accuire water rights, right of ways for canals, dams, ditches and laterals, and the use of water by location, purchase, rental, bond, lease, mortgage, deed of trust, decree of Court or otherwise, and as such property may be acquired in the ordinary course of business.

To deal in water rights, water locations, use of water, canals, water-ways, conduits, ditches, flumes or other conveyances, and to buy, sell,

lease, bond, rent or otherwise acquire or dispose of the same, or any in and to the same.

To construct canals, dams, ditches, water-ways and to sell and or purchase stock in the same, or rent, lease, bond or otherwise dispose of the same. To establish or construct or purchase dams, reservoirs, pumping plants, to dig or sink artesian wells for the purpose of reclaiming and farming lands with water and for opperating power stations, and to sell or rent the water or the power for mechanical, agricultural, domestic, city, town, village or community or individual purposes, and generally to use the water and the rights acquired, in a commercial way, and to buy and sell and deal in the same in the ordinary coars of business:

To take title to lands, and other realty, or personal property, as trustee, agent or in any fiduciary capacity, or relation, for individuals, companies, associations, syndicates, and for itself, and to improve and work the same.

To bond, lease, sell, mortgage or incumber by trust deed or otherwise any realty and personal property that the company may become possessed of for itself, or in acting in the capacity of agent, trustee, or in any other fiduciary relation.

To supply, rent, lease or sell water for lands under its irrigation system, and to rent water from its canals or water-ways, and to sell stock conveying an interest to such water rights and canals and other inter-pests in and to the same; and further to do all things within its corporate power that individuals might do to carry on its business as a land and water company.

FOURTH;

To raise funds by selling its shares of stock, either for cash at time of sale or by extending time of payment for such shares, such deferred payments not to extend to a greater length of time after sale than five years from first payment on same;

FIFTH;

The term for which it is to exist is fifty years, from and after date of of its incorporation.

SIXTH; analonity of all said members descring to become incorporated thing present and voting unamously decided.
