## ARTICLES OF INCORPORATION

## KNOW ALL MEN BY THESE PRECENTS:

That; the undersigned, all of whom are citizens of the United States and residents of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we hereby certify:

- 1. That the name of said corporation shall be GOVERNMENT GULCH MINING COMPANY, LIMITED.
- That the purposes for which said corporation is formed 2. are to acquire, own, enter, or lease mines and mineral lands of every kind and nature and description, also to acquire, own, enter or leave mill sites, water rights and terminal facilities; to work, prospect or develop mines and mineral lands of every nature or description, either for itself or other companies, corporations or individuals upon such terms and for such remuneration as it shall deem fit and proper, and to accept, take and hold mineral lands and claims of every kind and nature either as an entirety or any interest in the same; and to buy, sell, own or control stock of other corporations, as it deems fit and proper. To do everything that may be necessary or proper in the conduct of its business in the way of locating, prospecting, developing, acquiring, buying and selling mineral lands and mining claims of every kind, nature and description, and working such mines and the production of ores and minerals therefrom, and in the reducing such ores and minerals to the most merchantable value, and in doing the same, to contract, build, buy, sell, own and operate all necessary mills, smelters, machinery, roads, railroads, tramways, ditches, flumes, and such other property as shall be fit and necessary incarrying out the

objects herein stated. To sell, buy, lease mines and mining property of all kinds and property of every kind and nature and description, useful or necessary in operating and maintaining the same, and in reducing the ores and in refining the minerals taken therefrom upon commission, whether such commission be paid in money or otherwise.
