OF

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

**FIRST:** The name of the corporation is MARV'S MUSIC, INC.

**SECOND:** The period of its duration is perpetual.

**THIRD:** The purpose for which the corporation is organized is to transact any and all lawful business for which corporations may be incorporated within and under the Idaho Business Corporations Act.

**FOURTH:** The corporation shall have authority to issue Ten Thousand (10,000) shares, all of one class, having no par value.


