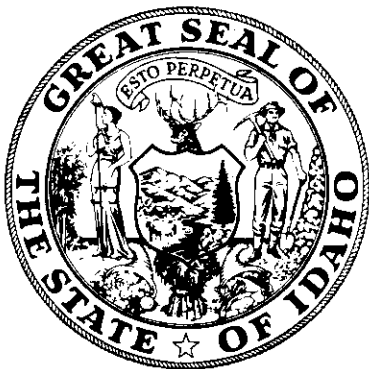

ARTICLES OF INCORPORATION  
OF  
THE SPORTS ACADEMY, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is The Sports Academy, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 10,000 at a par value of \$2.00 per share.

FIFTH: Provisions denying preemptive rights are: NONE

SIXTH: Any actions and/or decisions made by either the Board of Directors or the shareholders must be approved by unanimous vote. Other provisions for the regulation of the internal affairs of the corporation are contained in the By-Laws of the corporation.

SEVENTH: The address of the initial registered office of the corporation is 305 Steelhead Way, Boise, Idaho, and the name of its initial registered agent at such address is William Childers.

EIGHTH: There shall be two directors constituting the initial board of directors of the corporation and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:
