ARTICLES OF INCORPORATION
OF
LEGACY HOUSE, INC.

KNOW ALL MEN BY THESE PRESENTS that we, the undersigned being natural persons of full age and citizens of the United States of America, in order to form a corporation for the purposes hereinafter stated, under and pursuant to the provisions of the general corporation laws of the State of Idaho and acts amendatory thereof and supplemental thereto, do hereby certify as follows:

1. That the name of the corporation is
LEGACY HOUSE, INC. *as per Pat*
2. This corporation is formed and organized to engage in the general business of publishing manuscripts, books, articles or other written material of a historical nature, factual articles or other written material of a historical nature, factual articles dealing with current events, technical articles and fiction stories and any other work or written material that would be of interest for publication.
 - A. Further corporate purposes shall include publication and re-printing of pictures, reproductions of drawings and photographs of artworks.
 - B. Further, to purchase equipment, supplies, manuscripts, copywrites and any other thing or property, real or personal, necessary for the maintenance and expansion of the publishing business,
 - C. Any other lawful business purpose.
3. The corporation is to have perpetual existence.

4. The location and post office box of the registered office of the corporation is post office box 786, Orofino, Idaho, street address, 139 Johnson Avenue, Orofino, Idaho the registered agent who may be found at that address is Samuel F. Swayne.

5. The amount of the capital stock of this corporation shall be and is Twenty Thousand (20,000) shares of common stock at par value of one dollar each, making an aggregate stock of Twenty thousand (20,000) shares, which stock shall not be issued until fully paid for and once so issued shall be non-assessable.




