ARTICLE I: NAME: The name of this organization shall be **ROCKY POINT, INC.**

ARTICLE II: EXISTENCE: This corporation is organized as a for profit corporation of the State of Idaho, and its length of existence shall be perpetual.

ARTICLE III: PURPOSE: The purposes for which this corporation is formed are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act. 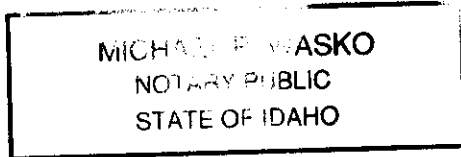
