 - If the director votes for or assents to the declaration of any dividend or other distribution of the assets of a corporation to its shareholders contrary to the provisions of the Idaho General Business Corporations Act.
 - If the director votes for or assents to the purchase of the corporation's own shares contrary to the provisions of the Idaho General Business Corporations Act.
 - 3. If the director votes for or assents to any distribution of assets of the corporation to its shareholders during the liquidation of the corporation without the

payment and discharge of, or making adequate provisions for, all known debts. obligations, and liabilities of the corporation.

4. For any transaction from which the director derives an improper personal benefit.
