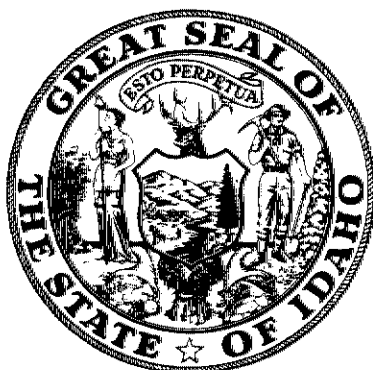

ARTICLES OF INCORPORATION  
OF  
WEST BONNER COUNTY FOOD BANK, INC.

THE UNDERSIGNED, acting as incorporators of a corporation under the Idaho Business Corporation Act, Chapter 3, Nonprofit Corporations, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is WEST BONNER COUNTY FOOD BANK, INC.

SECOND: The corporation is a nonprofit corporation.

THIRD: The period of its duration is perpetual.

FOURTH: The purpose for which this corporation is formed shall be and is to provide food, commodities, clothing, monies and other items to low income persons who are in need. And to that end, to acquire food, commodities, clothing and monies through contributors.

FIFTH: The address of the initial registered office of the corporation is Rt. 1, Box 167, Priest River, Idaho. All correspondence should be addressed to P.O. Box 1088, Priest River, Idaho, 83856.

SIXTH: The name of its original registered agent is  
JEANNIE DICKMANN.

SEVENTH: Voting shall be based upon a one (1) vote per  
member or shareholder basis.

EIGHTH: The number of directors of the corporation shall  
be three (3), the minimum provided by Idaho Code Section 30-315.
