

# ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned incorporators being of the age of eighteen years or more, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and do hereby certify as follows:

### ARTICLE I

The name of the corporation shall be: ALLEN CONSTRUCTION, INC.

#### ARTICLE II

The duration of the corporation shall be perpetual.

## ARTICLE III

The purposes for which the corporation is organized are as follows:

- (a) To engage in the business of construction;
- (b) To undertake all other business activities of any kind or nature for which businesses may be lawfully incorporated under the laws of the State of Idaho;
- (c) To do all other things necessary or incidental to the foregoing business purposes.

#### ARTICLE IV

The corporation is authorized to issue one class of shares, in a total artibunt of 5,000 shares. The stock shall bear no par value. Shares of stock of this corporation shall not be transferred or sold until said sale shall be approved by the Board of Directors of this corporation, in accordance with the duly adopted By-Laws of this corporation.

The capital stock of this corporation, after the amount of the subscription price or par value has been paid in, shall not be subject to assessment and no paid up stock and no stock issued is fully paid shall be assessed or be assessable.
