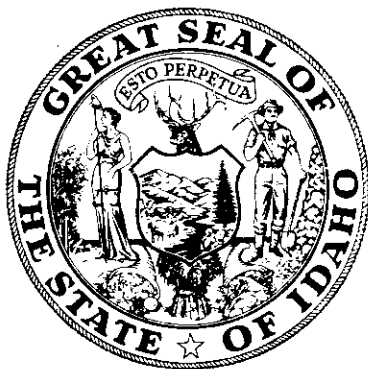

Pursuant to the provisions of Title 30-1-61 of the Idaho Business Corporation Act, the undersigned adopt the following Articles of Amendment to the Articles of Incorporation of J.S. CO.:

FIRST: The name of the corporation is J.S. CO.

SECOND: The following Amendment to the Articles of Incorporation was adopted by the Board of Directors of the corporation on March 22, 1983;

Article I of the Articles of Incorporation shall be amended in its entirety, to read as follows:

"The name of the corporation shall be JACKLIN SEED COMPANY."


THIRD: The designation and number of outstanding shares of each class entitled to vote thereon as a class are as follows:

FOURTH: The number of shares of the corporation outstanding at the time of such adoption was 3,000; and the number of shares voted for such amendment was 3,000; and the number of shares voted against such amendment was -0-.

FIFTH: This amendment affects no change in the total stated capital of the corporation which remains at 50,000.
