The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

- 1. NAME: The name of the corporation is CROSSROADS R.V. & SPORTS, INC.
- 2. **DURATION**: The period of it's duration is perpetual.
- 3. **PROFIT**: This is a profit corporation.
- 4. <u>PURPOSES</u>: The purpose or purposes for which the corporation is organized is to acquire, own and operate a retail recreational vehicle business and for the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
