Following proper notice and in accordance with its established ~~by STATE THE BOARD~~ of Directors of the Idaho, Community Action Partnership Association of Idaho, Inc. met on February 11, 2015, in Boise, Idaho, and adopted the following amendment to its Articles of Incorporation. The following amendments were adopted by unanimous vote of the six Directors present:

1. Article IV, is amended to read in its entirety: Charter membership of this corporation shall include the Grantees of the State of Idaho, administering at least one of the following funding sources: Community Service Block Grant (CSBG), Low Income Energy Assistance Block Grant (LIHEAP), and/ or Weatherization Assistance Program funding (WAP). Further membership shall be provided in the by-laws of the corporation.
2. Article IX, first sentence, is amended to read in its entirety: The registered office of this corporation is 3350 West Americana Terrace, Suite 360, Boise, Idaho, 83706.

These amendments are submitted by the President and the Executive Director of the corporation, who were directed by the Board to accomplish these amendments in accordance with Idaho statutes.


