ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, hereby adopt the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation shall be VAN HORNE & ASSOCIATES, INC.

ARTICLE II

The period of existence and duration of the life of this corporation shall be perpetual.

ARTICLE III

This corporation is organized for the purpose of the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV

The total authorized number of shares of the corporation shall consist of TWO THOUSAND FIVE HUNDRED (2,500) shares of Common Stock having a par value of ONE HUNDRED AND 00/100 (\$100.00) Dollars per share for a total value in stock of TWO HUNDRED FIFTY THOUSAND AND 00/100 (\$250,000.00) Dollars, all of one (1) class denoted Common Stock, each share being entitled to one (1) vote.

ARTICLE V

There are no provisions denying preemptive rights.

Provisions for the regulation of the internal affairs of the corporation are to be set forth in the Bylaws of the corporation.
