

- d) all assets of Chilla Villa, Inc to be transferred to a partnership called Chilla Villa with the following ownershi: Helen E. Salmeier 89% (eighty nine percent)

Charles E. Adams 11% (eleven percent)
- e) there are no debts, obligations or liabilities for Chilla Villa, Inc.
- f) there are no pending law suits against Chilla Villa, Inc.
- g) The dissolution has received the unaninous consent of all the stockholders. The Board of Directors has voted unanimously to adopt a resolution of dissolution.


