ARTICLES OF INCORPORATION

FIRST: The name of the corporation is Addison Collision Repair, Inc..

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized is to provide a vehicle body repair services, and all other related business.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is one thousand (1,000) shares, with a par value of \$1.00 per share.
