**ARTICLES OF INCORPORATION
(Non-Profit)**

The Undersigned, in order to form a Non-Profit Corporation under the Provisions of Title 30, Chapter 3, Idaho Code, submits the following articles of incorporation to the Secretary of State.

ARTICLE I: NAME

The name of the Non-Profit Corporation shall be McCall Curling Club, Inc.

ARTICLE II: PURPOSE

The purpose of this non-profit corporation shall be the promotion of the game of curling. It will provide programs designed to educate interested persons about the sport of curling and attract, support and train athletes interested in amateur curling competition.

The corporation shall not be operated for profit and is organized to operate exclusively within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended from time to time, including, for such purposes, the making of distributions to organizations that qualify as exempt under such Section 501(c)(3).

ARTICLE III: REGISTERED OFFICE AND AGENT

The office shall be located in McCall, Idaho at 224 Nasi Lane, McCall, Idaho 83638, with a mailing address of PO Box 2575, McCall, Idaho 83638, and principal operation at the Manchester Ice & Event Centre, 200 East Lake Street, McCall, Idaho 83638.

The name of the registered agent is Myron Dan Gabbert, Yacht Club Building, McCall, Idaho 83638

ARTICLE IV: PERIOD OF DURATION

The period of duration of the non-profit corporation shall be perpetual.

ARTICLE V: BOARD OF DIRECTORS

The affairs of the Corporation shall be managed by its Board of Directors. The number of Directors serving on the Board of Directors shall be fixed in accordance with the Corporation's Bylaws and initially there will be seven. The Directors shall be elected by the membership of the organization of the Corporation.

ARTICLE VII: MEMBERSHIP DUES

classes of membership may be made exempt from such membership dues. The Board of Directors is authorized to fix the amount of membership dues from time to time, and to make them payable at such times or intervals, and upon such notice, and by such methods as the Board of Directors may prescribe.


ARTICLE VIII: DISTRIBUTION ON DISSOLUTION


