ARTICLES OF INCORPORATION

NOTLOC, INC

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Notloc, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is One Hundred Thousand Shares (100,000) at \$10.00 par value per share.

FIFTH: Shareholders shall have a preemptive right to acquire unissued or treasury shares or securities convertible into such shares or carrying a right to subscribe to or acquire shares. Such right shall be limited only by an affirmative vote of the holders of three-fourths of the shares entitled to vote thereon.

SIXTH: The address of the initial registered office of the corporation is 116 South 14th Avenue, Pocatello, Idaho 83201 and the name of its initial registered agent at such address is Chad L. Nielsen.
