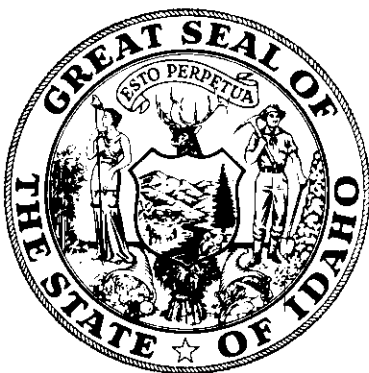

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION  
OF  
THORCO, INC.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

First: The name of the corporation is THORCO, INC.

SECOND: The following Amendments of the Articles of Incorporation were adopted by the sole Shareholders and the Board of Directors, on the 15<sup>th</sup> day of December, 1982, in the manner prescribed by the Idaho Business Corporation Act:

ARTICLE IV of the original Articles of Incorporation is hereby rescinded and the following is adopted as ARTICLE IV in its place and stead:

The total authorized capital stock of this corporation is \$100,000.00 consisting of 500 shares of Common Stock with a par value of \$100.00 per share and 500 shares of Preferred Stock with a par value of \$100.00 per share. The Common Stock and Preferred Stock shall have voting rights. The Preferred Stock shall have Preferred dividend rights. All stock shall be non-assesable. The corporation shall have the right to redeem all Preferred Stock at par value.

THIRD: The manner in which this Amendment effects a change in the amount of stated capital and the amount of stated capital as changed by the Amendment is as set forth in Paragraph Second.

FOURTH: The sole Stockholders of the Corporation are: CECIL D. THORPE, RUTH J. THORPE, JAMES M. THORPE, BRENDA K. THORPE, NICK THORPE, who are the Directors of the Corporation. All of the Directors and Stockholders shall execute these Articles of Amendment and by these Articles of Amendment acknowledge due and full compliance with Section 30-1-61 and correlated provisions of the Idaho Code relating to Amendment of Articles of Incorporation.
