J. H. Bradbury, President, and Adrian Nelson, Secretary, of the above named corporation, respectfully show unto L. E. Clapp, Secretary of State of the State of Idaho, as follows:

I.

The above named corporation was organized under the laws of the State of Idaho, and a certificate of incorporation issued therefor on the 14th day of November, 1955.

The above named corporation upon the proposal of its Board of Directors at the annual stockholders meeting held on June 18, 1966, adopted by a more than 2/3 vote of its stockholders a resolution amending Article IV of its Articles of Incorporation to increase the authorized capital stock of said corporation from 1,200,000 common shares with a par value of 25¢ each to 2,400,000 common shares with a par value of 25¢ each. That the said resolution increased the total capital stock from \$300,000 to \$600,000.

NOW, THEREFORE, J. H. Bradbury, President, and Adrian Nelson, Secretary, execute and acknowledge the following articles of amendment of R-G Mining Company, Inc.

The Board of Directors of R-G Mining Company, Inc., at a duly called meeting held on April 23rd, 1966, resolved to recommend to the stockholders of said corporation that Article IV of the Articles of Incorporation, providing for a capitalization of \$300,000.00 divided into 1,200,000 non-

assessable shares of common stock of the par value of 25¢ each be amended to increase the capitalization and authorized shares of stock to \$600,000.00 divided into 2,400,000 non-assessable common shares of the par value of 25¢ each; that said resolution was therefore submitted to the annual meeting of the shareholders held on June 18, 1966, and was adopted by a more than 2/3 vote in favor of so increasing the capitalization and number of shares.


Article IV of the Articles of Incorporation of the R-G Mining Company, Inc. will henceforth be as follows:
