# ARTICLES OF INCORPORATION FIRST BAPTIST CHURCH OF CASTLEFORD, IDAHO, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, do hereby associate ourselves together for the purpose of forming a religious corporation under and by virtue of the laws of the State of Idaho in such case made and provided, and do hereby adopt the following Articles of Incorporation:

FIRST: The name of the corporation shall be the FIRST BAPTIST CHURCH OF CASTLEFORD, IDAHO, INC. The registered office and postoffice address of said corporation is Castleford, Idaho, and its period of existence shall be perpetual.

SECOND: The purpose of this corporation shall be primarily for religious worship and for such other religious, charitable and humane purposes as form a part of church work; and it shall have power to acquire, hold, lease, mortgage, sell, convey and manage real and personal property as shall be necessary for the business of and to promote the object of such organization, but in no case for pecuniary profit.

THIRD: The government of said Church and the management of its affairs shall be vested in a board of five (5) trustees. The trustees shall have such powers as shall be conferred upon them by the By-laws of this corporation, and generally, shall have charge of the management and operation of the real property of said corporation.

FOURTH: The By-laws shall contain the requirements for membership of said Church.

FIFTH: That pursuant to notice duly published and legally given, at a special meeting of said Church on December 4, 1957, at the FIRST BAPTIST CHURCH OF CASTLEFORD, IDAHO, an election was held and a majority of the members present voted for and elected the following members as Board of Trustees and authorized

HEPWORTH LAWYER BUHL, IDAHO them to act as incorporators of said corporation: Edna Haley, Castleford, Idaho; James LaGrone, Buhl, Idaho; Ora Kinney, Castleford, Idaho; Alvin Barnes, Castleford, Idaho; and Howard Barnes, Buhl, Idaho. The said trustees above being the regularly elected trustees of the FIRST BAPTIST CHURCH OF CASTLEFORD, IDAHO, INC. That all of the above named incorporators are of full legal age and citizens of the United States.
