ARTICLE 1

NAME

All provisions of this Certificate of Incorporation shall be subject to amendment, consistent with the provisions of the Idaho Nonprofit Corporation Act and Section 501(c)(3) of the Internal Revenue Code of 1954, by the affirmative vote of all the members entitled to vote in respect thereof, given at the annual meeting or at any special meeting, provided that notice of the proposed amendment is included in the notice of such meeting.

ARTICLE 10

DISSOLUTION

Upon the dissolution of the Corporation, any assets

remaining thereafter shall be conveyed to such organization or organizations as shall be selected by the affirmative vote of a majority of the members entitled to vote in respect thereof, provided, however, that such organization or organizations shall be exempt under Section 501(c)(3) of the Internal Revenue Code.
