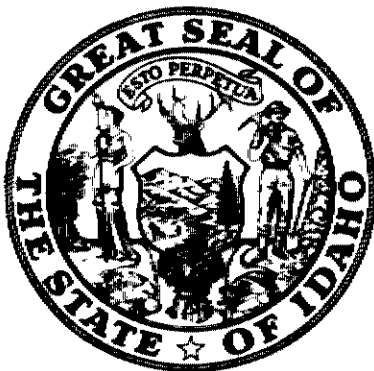

ARTICLES OF INCORPORATION

IDAHO WATER SAFETY INC., A NONPROFIT CORPORATION

ARTICLE I. The name of the corporation shall be Idaho Water Safety Inc.

ARTICLE II. The corporation shall be a nonprofit corporation. The corporation is an educational organization whose purpose is to develop and improve the skill and safety level of individuals who participate in boating and water sports. The corporation shall at all times operate as an educational organization within the meaning of section 501 (c)(3) of the Internal Revenue Code.

ARTICLE III. The duration of the corporation shall be perpetual.

ARTICLE IV. The purpose of the corporation shall be:

1. To encourage and promote general water safety education in the State of Idaho.
2. To offer boating safety and instructional courses for operators of sailboats, powerboats, and manually propelled craft.
3. To offer water safety classes to the public at large.
4. To promote an awareness of water safety in the public.
5. To serve as a clearinghouse of materials, equipment, information and activities for water safety training.
6. Serve as a support group and contributor to water safety programs offered by the Red Cross, water safety related agencies, and local units of the government.

ARTICLE V. Dissolution of the corporation shall be by two-thirds vote of the voting members as defined in ARTICLE VI. In the event of the dissolution of the corporation all assets shall be distributed to charitable and educational organizations within the meaning of Section 501 (c)(3) of the Internal Revenue Code.

ARTICLE VI. The corporation shall have two (2) types of membership: voting membership and associate membership.

1. Voting Membership - may be individuals or representatives of other organizations.
2. Associate membership - is limited to representatives of other organizations which by law, rule or policies are precluded from participating in the corporate operation of Idaho Water Safety, Inc.
3. Nothing in the ARTICLES OF INCORPORATION shall serve to prohibit an individual who represents another organization as an associate member from becoming a voting member in their own individual capacity.
4. The qualifications for membership shall be set forth in the bylaws.

ARTICLE VII. Board of Directors

1. The management of the corporation shall be vested in the Board of Directors elected by the voting membership.
2. The Board of Directors shall be elected in the manner prescribed in the bylaws.
3. The initial Board of Directors shall be comprised of the incorporators.
