ARTICLES OF INCORPORATION  
of  
PRESIDENT ENTERPRISES, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, all being citizens of the United States of America, this day having voluntarily associated ourselves together for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and we do hereby certify:

ARTICLE I

Name

The name of this corporation shall be PRESIDENT ENTERPRISES, INC.

ARTICLE II

Purpose

That the purposes for which this corporation is formed are as follows:

(a). To enter into the operation and management of a cafe and restaurant, and a bar and grill for the dispensing of food and alcoholic beverages, and to deal in all products and articles used in connection therewith, and to operate the merchandising and service business in connection therewith, in the State of Idaho, or in any state of the United States of America.

(b). To buy, sell, lease, or exchange real or personal property of every kind and nature and to mortgage the same from time to time.

(c). To borrow and to loan money upon either real or personal property; to become a mortgagor or mortgagee thereof, and to take and give assignments thereof.

(1).

(d). To buy, sell, trade, or otherwise negotiate, stocks, bonds, mortgages, and all other negotiable instruments of whatsoever kind and character.

(e). To do everything or things herein set forth to the same extent as fully as natural persons might do or could do in the State of Idaho, or in any state, country or place.

(f). To have offices, conduct its business and promote its objects within and without the State of Idaho, without restriction as to place or amount; and this corporation shall have the power to hold meetings within or without the State of Idaho as may be determined from time to time by its By-laws.

(g). In general, but in connection with the foregoing, said corporation shall have and exercise all of the powers conveyed by the State of Idaho upon business corporations, it being expressly provided that the foregoing enumeration of special powers shall not be held to limit or restrict in any manner such general powers.

### ARTICLE III

#### Duration

The period of existence and duration of the life of this corporation shall be perpetual.

### ARTICLE IV

#### Place of Business

The location and post office address of the registered office of this corporation in the State of Idaho, shall be 612 Main Street, Caldwell, Canyon County, Idaho.

### ARTICLE V

#### Stock

This corporation is authorized to issue one class of shares

of capital stock and shall be designated as common stock;

The total number of shares of common stock this corporation shall be authorized to issue is 250 shares;

That the par value of each of the shares of common stock shall be \$100.00 per share; aggregate par value of all stock, \$25,000.00.

#### ARTICLE VI

##### Incorporators

#### ARTICLE VII

##### Directors

The number of directors of this corporation shall be at least three (3) and such additional number of directors as may be determined from time to time by the By-laws of the corporation.

#### ARTICLE VIII

##### Liability of Stockholders

The capital stock of this corporation shall be non-assessable and the private property of the shareholders in this corporation shall

not be liable for the debts, obligations and liabilities of this corporation.

#### ARTICLE IX

##### Powers

The Board of Directors of this corporation shall have the power to repeal and amend the By-laws of this corporation and adopt new By-laws. Such power shall not extend to making or altering any By-laws, fixing the qualifications, classifications, term of office or compensation of the Board of Directors and this authority shall not be interpreted as taking from the shareholders that power and authority given to them by Section 30-133 Idaho Code, 1947, its amendments and additions.

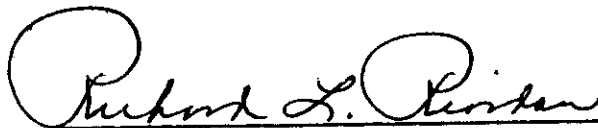
