

ARTICLES OF
INCORPORATION
OF THE
AFRICAN METHODIST EPISCOPAL CHURCH.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of incorporating under the laws of the State of Idaho, and in pursuance of the purposes for which we have been elected, as hereinafter set forth, a religious corporation to be known as AFRICAN METHODIST EPISCOPAL CHURCH of Pocatello, Idaho.

And we certify that the objects for which this corporation is formed are, to establish a church in the City of Pocatello, and State of Idaho, and in connection therewith suitable and customary organization for the purpose of public worship and religious training according to the rules and discipline of the African Methodist Episcopal Church of the United States of America under the supervision of a Bishop and authorities of said church in this jurisdiction, to take charge of the church building, estate, and properties, and the affairs and the temporalities thereof;

That the principal place of business of this corporation shall be in the City of Pocatello, State of Idaho; that the term of said corporation shall be fifty (50) years.

That the number of Directors who shall have the management of its affairs, as aforesaid, shall be six, and that the name of the Directors elected for the first year, are:--

Rev. J. B. Coleman, residing at Pocatello, Idaho;
Mack Johnson, residing at Pocatello, Idaho.
Al. Robinson, residing at Pocatello, Idaho;
John H. Pierson, residing at Pocatello, Idaho;
W. D. Carter, residing at Pocatello, Idaho;
O. L. Boyd, residing at Pocatello, Idaho.

That said directors were duly elected at a meeting of the members of said congregation duly convened and held at the Allen Chapel at 336 North Third Avenue, in the City of Pocatello, County of Bannock, and

State of Idaho, on the 11th day of February, 1924, for the purpose, among other things, of electing Directors to take charge and the management of its properties, temporalities, and affairs and to form this corporation.

That a majority of said members were then and there present and voted at such election for the above named Directors, as is more particularly set forth in the Certificate and Verification of the officers who conducted the election hereunto annexed and made a part of these ARTICLES.

THIS IS TO CERTIFY that at a meeting of the members of the AFRICAN METHODIST EPISCOPAL CHURCH for the purposes hereinafter set forth, held in the Allen Chapel at 336 North Third Avenue, Pocatello, Idaho, on the 11th day of February, 1924, a majority of the said members being then and there present who voted at said election. The Rev. G. B. Coleman was requested to preside and (Mrs.) Adda B. Albert to act as Secretary, with which requests they respectively complied.

The meeting then proceeded to the election of six Directors to take charge and the management, properties, temporalities and affairs of the African Methodist Episcopal Church and to form an incorporation under the laws of the State of Idaho, in furtherance of the objects for which the church is founded.

Motion to be made at meeting of AFRICAN METHODIST EPISCOPAL CHURCH
on February 11th, 1924.

MOTION I.

The following motion was offered by O. E. Boyd,
a member of the congregation of the African Methodist Episcopal Church:--

WHEREAS, on January 25th, 1924, notice was duly and legally given
to the effect that there would be held on February 11th, 1924, at the hour of 8:00
o'clock P. M., at the Allen Chapel, at 336 North Third Avenue, in the City of
Pocatello, Idaho, a special meeting of the members of the said African Methodist
Episcopal Church for the purpose of forming a corporation under and pursuant to
Chapter 196 of the Compiled Statutes of the State of Idaho, and,

WHEREAS, notice was duly published for two weeks in the Pocatello
Tribune, a newspaper published in said City of Pocatello, Bannock County, State of
Idaho, and a copy of said notice posted in said Allen Chapel,

NOW, THEREFORE, I move that the said African Methodist Episcopal
Church of Pocatello, Idaho, incorporate as a religious corporation under and
pursuant to the terms and provisions of Chapter 196 of the compiled Statutes of
the State of Idaho."

Motion was duly seconded by Mack Johnson a member of
the congregation of said church, and was duly put by the Chairman and carried.

It was moved by O. L. Boyd and seconded by Mattie Brooks
that the number of directors of said corporation be six. Motion
was put and carried.

The following named persons were placed in nomination to constitute
the Board of Directors of said corporation and received the number of votes
set opposite their respective names, and the ones receiving the highest number
of votes, the same were declared elected:.

It was moved by O. O. Boyd and seconded by Mattie

The following resolution was made by Al Robinson, a member of said church.

" I hereby move that all of the property of said African Methodist Episcopal Church, both real and personal, be transferred to the African Methodist Episcopal Church, of Pocatello, Idaho, a corporation, organized under the provisions of Chapter 196 of the Idaho Compiled Statutes, and that the Trustees of said Church be, and they are hereby authorized, empowered and directed to execute and necessary legal conveyances to transfer all of the title, right and interest of all the property of said church to the said African Methodist Episcopal Church, of Pocatello, Idaho, a corporation"

This motion was seconded by Mack Johnson, a member of the congregation of said Church and was duly put by the Chairman and carried.
