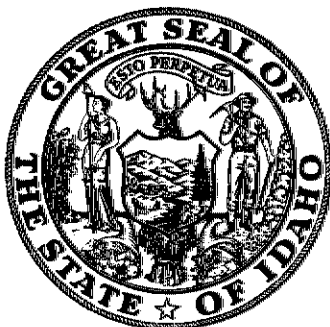

We the undersigned, in order to form a corporation to be organized by virtue of the laws of the State of Idaho here on March 11, 1995, at 595 East State Street, Suite B, in the City of Eagle, State of Idaho, establish the following Articles which state the organization to be:

ARTICLE I
