**CAPITAL STOCK**

The aggregate number of shares, which the corporation shall have authority to issue, is a thousand (1,000) shares of common stock, all of one class without par value.

**ARTICLE V**

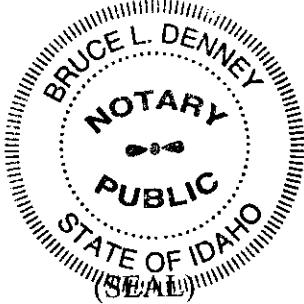
