ARTICLES OF INCORPORATION OF LINCOLN INN, INC., A CORPORATION

KNOW ALL MEN BY THESE PRESENTS, that we the undersigned, each and all being natural persons of full age and citizens of the United States, have this day and do hereby voluntarily associate ourselves together for the purpose of forming a corporation under the laws of the State of Idaho and we do hereby certify:

-1-

The name of said corporation shall be Lincoln Inn, Inc.

-2-

The purposes for which said corporation is formed are as follows:

- (a) To purchase, lease, or otherwise acquire, for cash or on terms of credit, real and personal property situate in the State of Idaho; to own, lease and operate thereon hotels and motels, and all adjuncts and accessories thereto, including restaurants, barrooms, and any other business associated or allied therewith; to do and perform any and all things for the pleasure, comfort, convenience, and amusement of guests in said hotels and motels;
- (b) To own the stocks of other companies and particularly of companies engaged in buying, selling and leasing real estate and hotels and in operating the same;
- (c) To own, conduct, operate, maintain and carry on the business of cabaret, night club, tavern, and restaurant and to sell and dispense food, beverages, and liquids of all kinds and to do any and all things necessary and pertaining to said business;

(d) To have authority to do and perform all things and acts specifically enumerated in and comprehended by Section 30-114, Idaho Code, and all other such acts as are necessary, desirable and expedient to accomplish its stated purposes

The term for which said corporation is to exist is perpetual;

The location and post office address of its registered office is Gooding, Idaho;

The total amount of authorized capital stock is 500 shares with the par value of \$100.00 a share with an aggregate value of \$50,000.00;

All such stock shall be common and non-assessable, and each and every share issued shall have the same rights and voting powers;

The business of this corporation shall be managed by a board;

The business of this corporation shall be managed by a board of at least three directors, and each director must be a stockholder in the corporation, provided, however, that any greater number of directors may be provided for by the by-laws of said corporation;
