ARTICLES OF INCORPORATION

OF

SLURETARY OF STATE

MARK S. CHOWN, M.D., P.A.

The undersigned, acting as incorporator of a corporation under the Professional Service Corporation Act, adopts the following Articles of Incorporation for such corporation:

 $\underline{FIRST}\colon \ \ \, \text{The name of the corporation is MARK S.}$ CHOWN, M.D., P.A.

SECOND: The period of its duration is perpetual, unless dissolved by action of the stockholders or by operation of law.

THIRD: The purpose or purposes for which the corporation is organized are: to render professional services to the public within the purview of the practice of medicine; and to do such acts and carry on such business as may be permitted by the Professional Service Corporation Act of the State of Idaho, subject to the limitations thereof.

FOURTH: The corporation shall have authority to issue TWENTY FIVE THOUSAND (25,000) shares, all of one class, \$1.00 par value.

FIFTH: Provisions denying preemptive rights are: NONE.

 $\underline{\text{SIXTH}}$: Provisions for the regulation of the internal affairs of the corporation are: NONE.

SEVENTH: The address of the initial registered office of the corporation is 312 W. Idaho, Boise, Idaho 83702, and the name of its initial registered agent at such address is Mark S. Chown.
