ARTICLES OF INCORPORATION

ARTICLE I

The period of the corporation's duration is perpetual.

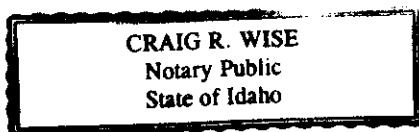
