AMENDED ARTICLES OF INCORPORATION

UL1 29

NAME: Basin Emergency Services Team, Inc. Idaho City Ambulance.

THIRD: Amended article: The purpose for which the corporation is organized is to provide emergency medical care and transportation for the sick and injured within the boundaries of B.E.S.T., Inc. as per agreement with Ada County and other ambulance crews in Boise County. In addition this corporation is organized for charitable, scientific, literary, religious, and educational purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code.

NINTH: Amended article: The duration of this organization shall be from now on, or until such time that it may be dissoved or disbanded by a vote of the general membership through a majority vote of the quorum (consisting of 2/3 of the general membership). This organization is not organized for profit, and no part of the net earnings shall inure to the benefit of any private shareholder.

ELEVENTH: Amended article: Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations for the organization, the remaining assets shall be distributed to a nonprofit fund, foundation or corporation which has established its tax exempt status under section 501(c)(3) of the Internal Revenue Code.

TWELVTH: Amended article: Notwithstanding any other provision of these articles the corporation shall not carry on any other activities nof permitted to be carried on by an organization exempt from Federal Income tax exempt status under section 501(c)(3) of the Internal Revenue Code.

AMENDMENT WAS ADOPTED: Amended Articles were adopted September 22, 1981. A quorum was present and the amendment received a majority of the votes.
