ARTICLES OF INCORPORATION
OF
KNIGHTS OF PYTHIAS LODGE, ACME NO. 15, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, whose names are hereto affixed, all of whom are bona fide residents and full-age citizens of the United States of America, do under and in pursuance of Idaho Code Title 30, Chapter 3, and general corporation laws of said State, hereby organize, constitute and associate ourselves in accordance with these Articles, into a body politic, and corporate NOT for profit, for the purposes hereinafter set forth, and to that end we execute these Articles of Incorporation, and hereby certify, set forth, and declare as follows:

I.

N A M E

The name of this corporation is KNIGHTS OF PYTHIAS LODGE, ACME NO. 15, INC.

II.

NON-PROFIT CORPORATION

This corporation is a non-profit corporation.

III.

DURATION

The duration of this corporation is perpetual.

IV.

PURPOSES

To promote friendship among men, to relieve suffering, and to do any act that will promote friendship, charity and benevolence, including, but not limited therein; service by works and finances for health, welfare, and educational causes;

To effect the establishment and operation of lodge facilities for the pleasure, recreation, and entertainment of members of the lodge and eligible guests;

To purchase, lease, hold, sell, develop, erect, build, mortgage, deed in trust, convey, or otherwise acquire and dispose of real and personal property, and to maintain and operate the same for the use and enjoyment of all the members of the lodge, subject to such rules, regulations, and restrictions as are set forth in the bylaws of this corporation and as determined by action of the board of directors in regular meeting;

To do all and everything necessary, suitable, and proper for the accomplishment of any of the purposes or attainment of any of the objects heretofore set out or mentioned, either alone or in association with other individuals, corporations, or partnerships, including but not limited to, the county, state, federal, and municipal bodies and authorities; and, in general, to do and perform such things and acts and transact such business in connection with the foregoing objects not inconsistent with the general laws of this land or the objects and aims of Knights of Pythias Lodge, Acme No. 15, Inc.

V.

MEMBERSHIP

The corporation shall have members, and management of the affairs of the corporation shall be in its members; however, the membership shall have a board of directors as outlined herein, and the authority of such board shall be as outlined in the corporate By-Laws as said By-Laws may be amended from time to time.

VI.

LOCATION AND AGENT

The location is in Boundary County, Idaho; and the street address of the registered office of the corporation in the State of Idaho is 102 Grant Street, Bonners Ferry, Idaho; and the name of the registered agent is Myrle A. Douglas at the above address.

VII.
