Guided by these principles and governed by the following Articles of Incorporation, and By-laws in support thereof, we hope to be worthy followers of THE ANCIENT AND ACCEPTED SCOTTISH RITE OF FREEMASONRY".

A-R-7-1-0-L-E--I.

The name of this corporation is the AMERICAN MASONIC PEDERATION.

A-R-T-I-C-L-E--II.

The purpose for which this corporation is formed, and its chief objects and business, shall be to dispense Charity to its members, to premete Harmony, Peace and Brotherly Love between Free Masonic degrees dust Masonic work, to transmit the authority to confer Masonic degrees and to confer the same, to establish, govern and control Symbolic Masonic Lodges in locations where no Grand Lodge of the A.A.S.
