ARTICLES OF INCORPORATION

I, the undersigned person, citizen of the State of Idaho, being of legal age and hence capable of contracting, hereby enter into an association to form a corporation under the laws of the State of Idaho and do hereby certify as follows:

- 1) The name of the corporation shall be Bonnie's Salon of Beauty, Inc.
- 2) The general nature of the business conducted by this corporation shall be a beauty shop, including all types of hair styling dressing, etc.
- 3) In the conduct of this business, this corporation shall also have the following powers:
  - a) to enter into and perform contracts of any and all kinds, to become a partner in any lawful business venture, to acquire and deal in the stock of other corporations, or its own stock and security should the need arise,
  - b) to establish pension and profit sharing plans,
  - c) to acquire other businesses, either through purchases of assets or merger of corporate structures, or by the exchange of cash, stock, securities, or other consideration,
  - d) to borrow money as necessary and to the extent permissible by law,
  - e) to purchase, lease, or otherwise deal in personal property and equipment as necessary to the conduct of business
  - f) to purchase, hold, lease, mortgage, or otherwise deal in real property of all kinds,
  - g) to apply for and register patents, trade marks, trade names, and any other intangible objects which may be necessary to the conduct of this business,
  - h) to carry on and conduct any other lawful business in the context of the forgoing powers, as well as to use any other powers available to corporations under the laws of the State of Idaho not specifically claimed or herein enumerated.

- 4) The amount of capital stock which this corporation shall be authorized to issue is 50 shares of a par value of \$ 100 each, making a total capital of \$ 5,000.
- 5) This business shall begin with the initial capital amount of \$ 500.
- 6) The existence of this corporation shall be perpetual, SUBJECT TO THE PROVISIONS for dissolution of corporations, under the laws of the state of Idaho.
- 7) The initial registered office of this corporation shall be located at 146 North Elm St. , Twin Falls, Idaho 83301 and the initial registered agent, whose address is the same as that above, shall be Bonnie Henson.
