

ARTICLES OF INCORPORATION

OF

IDA-TEX CORPORATION

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being natural persons of legal age, and at least two-thirds of them being citizens of the United States, in order to form a corporation for the purposes hereinafter stated pursuant to the Business Corporation Act of Idaho, do hereby certify as follows:

FIRST:

The name of the corporation is Ida-Tex Corporation.

SECOND:

The purposes for which said corporation is formed are: to explore and develop sources of petroleum and mineral deposits; to develop, process and refine petroleum and natural gas products; to enter into all manner of contracts, leases and other forms of property acquisition as would pertain to the exploration, development, acquisition and sale of petroleum gas and mineral resources in whatsoever geographic location not specifically precluded by these Articles; and to perform all other related business activities and to transact any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLES OF INCORPORATION

THIRD:

The location and post office address of the registered office of the corporation is 106 Hillcrest Road, Lewiston, Nez Perce County, Idaho, and the registered agent is Jack L. Curtin.

FOURTH:

The total authorized number of par value shares is 100,000 shares of the par value of \$1.00 per share, aggregate par value, \$100,000.

FIFTH:

The name and post office address of the incorporator and the number of shares subscribed by said incorporator is as follows:

SIXTH:

The private property of the stockholders shall not be subject to the payment of corporate debts to any extent whatever.

SEVENTH:

The board of directors shall consist of at least one, but not more than seven directors, namely: Mickey J. Stipe, whose address is set forth in paragraph Fourth above, or such other number as shall be established by the Bylaws of the corporation. Any vacancies occurring in the office of any director, however

occasioned, may be filled by the remaining members of said board. On failure of the board to elect, a special meeting of the stockholders shall be called to fill the vacancy.

EIGHTH:

The existence of this corporation is to be perpetual.

NINTH:

The directors shall have the power to make and to alter or amend the Bylaws, to fix the amount to be reserved as working capital and to authorize and cause to be executed mortgages and liens without limit as to the amount upon the property and franchise of this corporation.

TENTH:

This corporation shall indemnify any and all of its directors or officers or former directors or officers or any person who may have served at its request as a director or officer of another corporation in which it owns shares of capital stock or of which it is a creditor against expenses actually and necessarily incurred by them in connection with the defense of any action, suit or proceeding in which they, or any of them, are made parties, or a party, by reason of being or having been directors or officers or a director or officer of the corporation, or of such other corporation, except in relation to matters as to which any such director or officer or former director or officer or person shall

be adjudged in such action, suit or proceeding to be liable for negligence or misconduct in the performance of duty. Such indemnification shall not be deemed exclusive of any other rights to which those indemnified may be entitled, under any bylaw, agreement, vote of stockholders, or otherwise.

I, the undersigned, for the purpose of forming a corporation under the laws of the State of Idaho, do make, file and record this certificate and do hereby certify that the facts herein stated are true; and I have accordingly hereunto set my hand and seal.
