CERTIFICATE OF PROCEEDINGS FOR EXTENSION OF THE TERM OF CORPORATE EXISTENCE OF THE LENROOT CANAL COMPANY

We, the undersigned, Alvin Munns , President, and George Briggs, Jr, the Secretary, of the Lenroot Canal Company, do hereby certify that a special meeting of the stockholders of the Lenroot Canal Company was called according to law and according to the By-Laws of said company for the purpose of extending the term of corporate existence of said company by making it perpetual.

Said meeting was held June 23rd , 1952, at 8:00 o'clock P.M. at the Archer Church in Archer Madison County, Idaho, and was conducted according to law; that more than two-thirds of the stockholders being present and voting thereon; it was moved, seconded and unanimously resolved as follows:
"BE IT RESOLVED:"

"Whereas, the term of corporate existence of the Lenroot Canal Company has expired and it being the desire of the stock-holders of the Lenroot Canal Company to extend the corporate existence by making such existence perpetual, and

"WHEREAS, more than two-thirds of the issued, outstanding capital stock of said corporation is represented and voting at said special meeting,

"BE IT RESOLVED that by virtue of Section 30-160, Idaho Code, the term of existence of said Lenroot Canal Company is hereby extended to be perpetual.

"NOW, THEREFORE, the President and Secretary of the corporation shall be, and they are hereby authorized, empowered and directed to prepare and certify to the Secretary of State of the State of Idaho in triplicate the proceedings of this matter relative to the extension of the term of corporate existence of the Lenroot Canal Company, which existence has been made perpetual as heretofore set forth."

We, the undersigned, hereby certify that the foregoing Resolution is a full, true and correct copy of the proceedings included in the minutes of the undersigned secretary and part of the official records of said corporation; that more than two-thirds of the issued, outstanding capital stock of said corporation voted for the passage of said resolution at said meeting held June 23rd, 1952, as aforesaid.
