# NON-PROFIT CORPORATION

This corporation is a religious corporation and is not of the for the private gain of any person. This corporation electric governed by all the provisions of the Idaho Nonprofit Corporations.

#### DURATION

This corporation shall continue and exist perpetually unless it is dissolved or its existence is other wise terminated under the provisions of law. Upon dissolution of the corporation, the Board of Directors, after paying or adequately providing for debts and obligations of the corporation, shall distribute the remaining assets of this corporation to an organization(s); established and operated exclusively for religious purposes and tax exempt under Section 501 (c) (3) of the Internal Revenue Code of 1954.

## PURPOSE / OBJECTIVES

The purposes of New Beginnings are:

- A. To propagate the Gospel of the Lord Jesus Christ and to struct the saints to worship the Lord in spirit and in truta; w
- B. To establish and maintain a church and to provide a place of worship in the County of Idaho, State of Idaho.
- C. To establish, maintain, and conduct schools for the religious instruction of the young and to further other religious work.
- D. To purchase, lease, exchange or otherwise, acquire, own, hold, develop, operate, manage, sell, assign, build upon, transfer, convey, mortgage, deed in trust, hypothecate, or otherwise dispose of any real and personal property of every class and description.
- E. To borrow or raise monies for any of the purposes of this corporation.
- F. To receive money or property of all kinds by contribution, gifts, donation, devise or bequest from any person or persons, or other source or sources whatsoever, and to hold and apply the same for the use and benefit of this corporation for the purposes hereinabove specified, and to do any and all things necessary, suitable, convenient or proper for, or in connection with, or incidental to, the accomplishment of any one or more of the objects herein enumerated, or designed directly or indirectly to promote the interests of this corporation; and in general to do

any and all things and exercise any and all powers which it may now or hereafter be lawful for this corporation to do or to exercise under the laws of the State of Idaho that may now or hereafter be applicable to this corporation.

- G. This corporation is not formed with a view to and expressly prohibits pecuniary gain or profit of the employees, officers, or directors thereof.
- H. To provide oversight to the departments and ministries of the local church as well as abroad as they pursue their vision and biblical mandates of worship, evangelism, pastoral care, education, and charity.
- I. To train and promote Missionary activity and plant churches.
- J. To enter into, make, perform, and carry out contracts of every type, kind, and nature pursuant to the aforesaid purposes.

#### POLITICS

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, nor participate in or intervene in (including publishing or distributing statements) any political campaign on behalf of any candidate for public office.

### REGULATION

This corporation shall be regulated by its Constitution and By-Laws; various departments by its Department Procedure Manual; employees by its Employee Personnel Manual; and the church in general shall follow principles of the Scriptures for conducts and beliefs.

#### **MEMBERSHIP**

There are no memberships to the corporation. The corporation shall be governed by a Board of Directors (Servants Council). The minimum number of Directors shall be two.
