The undersigned, acting as incorporators under the provisions of the Idaho Business Corporation Act, adopt the following Articles of Incorporation:

1. NAME. The name of the corporation is:

2. DURATION. The period of its duration is  
perpetual.

3. PURPOSES. The purpose for which the  
corporation is organized is the transaction of any or all  
lawful business for which corporations may be incorporated  
under the Idaho Business Corporation Act.
