ARTICLES OF INCORPORATION

of

PUFAHL TRUCKING INC.

KNOW ALL MEN BY THESE PRESENTS, that I, the undersigned, Dennis S. Voorhees, who is a citizen of the United States and natural person of full age, has this day resolved to form a corporation for profit under the laws of the State of Idaho, and I do hereby certify and state:

I

CORPORATE NAME

That the name of the corporation is and shall be PUFAHL TRUCKING INC.

II

DURATION

That subject to dissolution in the manner provided by law, the life of this corporation shall be perpetual.

TTT

PURPOSES AND POWERS

That the purposes for which this corporation is formed include, but are not limited to, commercial trucking. This corporation shall have the right to exercise all powers conferred upon general business corporations by the laws of the State of Idaho.

IV

REGISTERED OFFICE AND AGENT

That the location and post office address of the registered office of this corporation is $165\frac{1}{2}$ Eastland Drive, Twin Falls, Idaho,

83301. The registered agent of this corporation is Glenn Pufahl, whose offices and post office address are the same as that of the registered office.

V

AUTHORIZED STOCK

The total authorized stock of this corporation shall be divided into one hundred (100) shares, all of which shall be without par value and shall comprise a single class of stock. The Board of Directors may, from time to time, fix the consideration for which shares without par value shall be issued and sold. Said stock shall be nonassessable. The name and address of the incorporator is Dennis S. Voorhees, P. O. Box 922, 761 Juniper, Twin Falls, Idaho, 83301.

The following persons have jointly subscribed to and shall be jointly issued shares of stock in the number indicated: Glenn and Gail Pufahl, twenty-five (25) shares.

VI

CONSIDERATION FOR STOCK

All or any portion of the capital stock may be issued for cash or in payment for real or personal property, services, or any other right or thing of value, for the uses and purposes of the corporation, and when so issued shall become and be fully paid, the same as though paid for in cash at par, and the directors shall be the sole judges of the value of any property, right or thing acquired in exchange for capital stock. Each issued and fully paid share of stock shall be nonassessable.

VII

CAPITAL STOCK ADJUSTMENTS

From time to time the capital stock may be increased according to law, and may be issued in such amounts and proportions as shall be determined by the Board of Directors, and as may be permitted by law.

VIII

PERSONAL LIABILITY OF STOCKHOLDERS

The personal property of the stockholders shall not be subject to the payment of corporate debts to any extent whatsoever.

IX

MANAGEMENT

That the business of the corporation shall be managed by a Board of Directors composed of two (2) persons. The names and residences of the persons who are appointed to act as directors until the first meeting of their successors are Glenn Pufahl and Gail Pufahl, 369 Polk Street, Twin Falls, Idaho, 83301.
