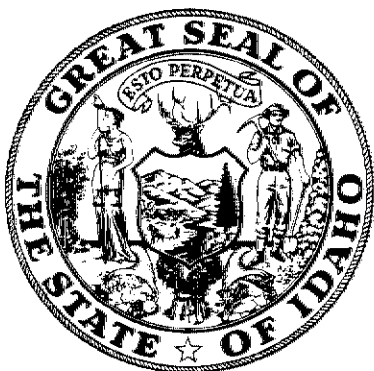

ARTICLES OF INCORPORATION

OF

THE UNDERSIGNED, acting as incorporators of a nonprofit corporation under the General Idaho Nonprofit Corporation Law, adopt the following Articles of Incorporation for such nonprofit corporation.

FIRST: The name of the corporation is Klothes for Kids, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: To solicit donations from various businesses and individuals in the community to purchase much needed winter clothing for children of less fortunate families in the Twin Falls area. All monies raised or donated will be used for this purpose.

FOURTH: This corporation is organized pursuant to the General Nonprofit Corporation Law of the State of Idaho. Pecuniary profit is not the object of this corporation, and it shall have no capital stock.

FIFTH: The name of the initial registered agent is Burton Webb, Jr., and the location and post office address of the registered office of this corporation, the place where the principal business of this corporation is to be transacted is 1972 Maple, Twin Falls, Idaho 83301.

SIXTH: The terms of admission and qualifications for membership in this corporation shall be provided for in the bylaws to be adopted.

SEVENTH: The names and post office addresses of the initial board of directors or trustees to serve until the election of their successors are as follows:

EIGHTH: The board of directors or trustees of this corporation shall consist of not less than three. The exact number shall be governed by the bylaws. The officers shall consist of the President, Vice President, Secretary, and Treasurer.

NINTH: The corporation shall adopt bylaws for the regulation and government of its affairs and in accordance with the laws of the State of Idaho. Such bylaws may be changed from time to time by a majority vote of the members of the corporation at any regular or special meeting.
