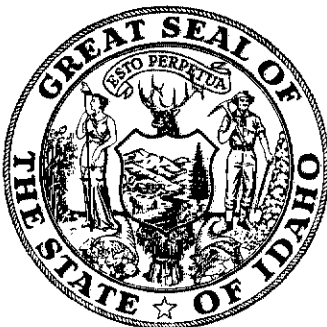

FIRST. The name of this Corporation is J.M.H.C., Inc.

SECOND. Its registered office in the State of Idaho is to be located at 1685 N.W. 13th Avenue, Meridian, Idaho 83642 and the registered agent is to be Joan Cloud whose address is 1685 N.W. 13th Avenue, Meridian, Idaho 83642.

THIRD. The nature of the business and the objects and purposes proposed to be transacted, promoted, and carried on are to engage in any lawful act or activity for which corporations may be organized under the General Corporation Laws of Idaho.

FOURTH. The amount of total authorized capital stock of the Corporation is divided into 150 shares of no par value. All 150 of such shares are hereby issued to the incorporator, Joan Cloud.

FIFTH. The name and mailing address of the incorporator is as follows: Joan Cloud, 1685 N.W. 13th Avenue, Meridian, Idaho 83642.

SIXTH. The powers of the incorporator are to terminate upon filing of the Certificate of Incorporation, and the name and mailing addresses of the persons who are to serve as directors until their successors are elected are as follows:

SEVENTH. All of the Corporation's issued stock, exclusive of treasure shares, shall be held of record by not more than five (5) persons.

EIGHTH. All of the issued stock of all classes shall be subject to the following restriction on transfer permitted by Section 30-1-54(g) of the General Corporation Law:

Each stockholder shall offer to the corporation or to other stockholders of the corporation a thirty (30) day right of "first refusal" option to purchase his or her stock should he or she elect to sell his or her stock.

NINTH. The Corporation shall make no offering of any of its stock of any class which would constitute a "public offering" within the meaning of the Securities Act of 1933, as it may be amended from time to time.

TENTH. The period of duration of J.M.H.C., Inc. is perpetual.
