



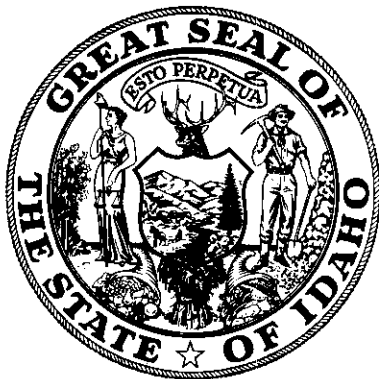
**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

OF

NORDEL, INC.

ARTICLE I.

The name of the corporation is NORDEL, INC..

ARTICLE II.

The period of its duration is perpetual.

ARTICLE III.

Its purpose is principally to carry on the business of developing and improving real property, and in conjunction therewith the following:

- A) To purchase, lease, exchange, hire or otherwise acquire lands or any interests therein, whatsoever and wheresoever situate;
- B) To erect, construct, rebuild, enlarge, alter, improve, maintain, manage, and operate houses, buildings, or other works of any description on any lands owned or leased by the corporation, or upon any other lands;
- C) To sell, lease, sublet, mortgage, exchange, or otherwise dispose of any of the lands or any interests therein, or any houses, buildings, or other works owned by the corporation;
- D) To buy, sell, lease, mortgage, exchange, manage, operate, and deal in lands or interests in lands, houses, buildings, or other works;

- E) To do all things not prohibited by law in pursuance of the above, and to otherwise transact all business not forbidden by law.

ARTICLE IV.

The corporation shall have the authority to issue twenty-five thousand (25,000) shares of stock, all of one class, \$1.00 par value.




