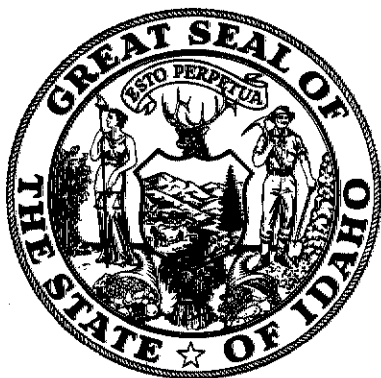
### CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION

OF

CENTRAL EQUIPMENT COMPANY

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Central Equipment Company.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is five thousand (5,000) shares, all of which are to be with a par value of \$100.00 for each share.

FIFTH: The address of the initial registered office of the corporation is 341 West 400 South, Jerome, ID 83338, and the name of its initial registered agent at such address is Larry Holtzen.

SIXTH: The number of directors constituting the initial board of directors of the corporation is three, and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:
