A special meeting of the stockholders of the Boise Payette Lumber Company, a Corporation organized and existing under the laws of the State of Idaho, was held at the office of said Corporation on the second floor of the Empire Building, Boise City, Idaho, being the principal place of business of said Corporation; on the 20th day of September, 1918, at 2 o'clock in the afternoon in accordance with the resolution and order of the Board of Directors of said Corporation calling said meeting and notice thereof given as hereinafter set forth. There were present in person or by proxy at said meeting, the shareholders owning and holding sixty-nine thousand, six-hundred and forty shares, subscribed, capital stock of said corporation. On motion duly made, seconded and carried, the chairman caused the secretary to read the resolution of the Board of Directors calling said meeting of stockholders which said resolution was duly passed by a majority vote of all the directors of said corporation, and calling said special meeting of the stockholders to be held

on the 30th day of September, 1918, at the office of the corporation in the Empire Building in Boise City, Idaho, for the purpose of considering and acting upon the proposition of increasing the capital stock of said Corporation from seven-million dollars, divided into seventy-thousand chares of the per value of one-hundred dollars each, to not to exceed ten-millon dollars, divided into one-hundred thousand shares of the par value of one-hundred dollars each.

The chairman crused the secretary to read the published notice calling the said special meeting of the stockholders for the purpose oforesaid. Said published notice being in words and figures as follows to-wit:

## RESOLUTIONS.

TWHEREAS, the Boise Payette Lumber Company is a corporation under the laws of the State of Idaho, with its principal place of business at Boise City, Ada County, Idaho, whose capital stock at the time of its indorporation was seven million (7,000,000) dollars, all of which has been paid for in full at par, and certificates of full paid stock issued therefor, and whereas the stockholders of said Boise Payette

humber Company now find said amount of capital stock insufficient for the carrying out of the purposes for

which the corporation was organized.

NOW THEREFORE, Be it Resolved by the stockholders of said Boise Payette Lumber Company, representing more than two-thirds of the total of 70,000 shares of the fully paid up and issued capital stock of said company, that the capital stock of said Boise Payette Lumber Company be and the same is hereby increased so that said capital stock shall now be ten million (10,000,000) dol-lars, and that the Seventh Article of its Articles of Incorporation be and the same is hereby amended so that it shall now be as follows:

Seventh: That the amount of its capital stock is ten million (10,000,000) dollars, and that the number of shared into which it is divided is one
