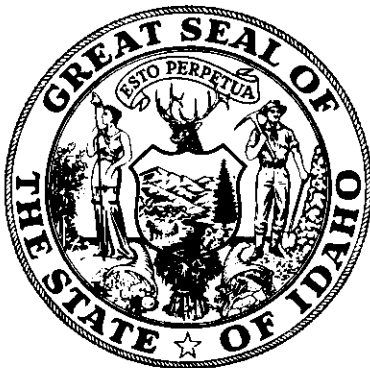

ARTICLES OF AMENDMENT OF BLAINE COUNTY
COMMUNITY EDUCATION, INC.,
A NON-PROFIT CORPORATION

Pursuant to the provisions of Section 30-325 through §30-327, the Idaho Non-Profit Corporation Act, the undersigned non-profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is Blaine County Community Education, Inc.

2. The non-profit corporation has no members, but the Articles of Amendment were adopted by a majority vote of the Directors in office who consented and ratified to the Amendment without the need for a special meeting of the Board of Directors.

3. The following Amendments to the Articles of Incorporation of Blaine County Community Education, Inc., a non-profit corporation, were approved by the Board of Directors:

(a) A new paragraph 8 which is in addition to the original Articles of Incorporation of Blaine County Community Education, Inc., is added, and that paragraph reads as follows:

ORIGINAL

8. This corporation is organized exclusively for religious, charitable, scientific, literary or educational purposes within the meaning of §501(c)(3) of the Internal Revenue Code.

(b) A new paragraph 9 which is in addition to the original Articles of Incorporation of Blaine County Community Education, Inc., is added, and that paragraph reads as follows:

9. Notwithstanding any other provisions of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax under §501(c)(3) of the Internal Revenue Code.

(c) A new paragraph 10 which is in addition to the original Articles of Incorporation of Blaine County Community Education, Inc., is added, and that paragraph reads as follows:

10. Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a non-profit fund, foundation or corporation which has established its tax exempt status under §501(c)(3) of the Internal Revenue Code.
