ARTICLE IV
CAPITAL STOCK

The aggregate number of shares which the corporation shall have authority to issue is one hundred (100) shares of common stock, all of one class without par value.

ARTICLE V
INITIAL REGISTERED OFFICE AND AGENT

The initial registered office of the corporation is Route 1, Box 83, Moore, Idaho, 83255; The name of the initial registered agent at that office is Joel V. Dye, M.D.

ARTICLE VI
DISTRIBUTIONS

The shareholder of the corporation may, from time to time, distribute to himself out of capital surplus of the corporation a portion of its assets, in cash or property, subject to the following provisions;

(a) No such distribution shall be made at a time when the corporation is insolvent or when such distribution would render the corporation insolvent;

(b) No such distribution shall be made unless it is authorized by the affirmative vote of the holders of a majority of the outstanding shares;

(c) Each such distribution, when made, shall be identified as a distribution from capital surplus and the amount per share disclosed to the stockholder receiving the same concurrently with the distribution thereof.

The number of directors constituting the initial Board of Directors of the corporation is (1), and the name and address of the person who is to serve as Director until the first annual meeting of Stockholders or until his successor is elected and qualified is:



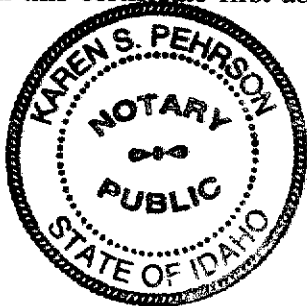
