Article I.

NAME. The name of the corporation is Sunfresh Idaho Company.

Article II.

DURATION. The period of its duration is perpetual.

Article III.

PURPOSE. The purpose for which the corporation is organized is: to purchase and prepare food products for distribution; to trade for agricultural products; and to engage in 14 all other business transactions not forbidden by law.

Article IV.

The aggegate number of shares which the corporation STOCK. shall have authority to issue is 100 with a par value of \$250.00 per 17 share.

PREEMPTIVE RIGHTS. Provisions denying preemptive rights are: None
